WHAT ARE MANAGED LANES?

Managed Lanes are a set of lanes separated from general-use lanes to help manage congestion.

Managed Lanes work because users are given an option to use the Managed Lanes or remain in the general-use lanes. Managed Lane Users – like trucks, transit or the motoring public traveling longer distances, can avoid slowdowns, merging and congestion at exits – all while reducing the number of vehicles traveling in the general-use lanes. This choice helps reduce delays, manage congestion, and keep travel times reliable for motorists.

WELCOME

The Florida Department of Transportation (FDOT) District One welcomes you to the public kickoff meeting for the I-75 North Corridor Managed Lanes Study. The purpose of this project is to analyze and put in place an integrated and comprehensive transportation solution that meets the needs of the near term and accommodates the evolving and innovative transportation solutions of tomorrow. This capacity improvement project involves the potential construction of Managed Lanes in each direction on I-75 from North River Road in Sarasota County to Moccasin Wallow Road in Manatee County. General-use lanes, collector-distributor roadways, auxiliary lanes and interchange operational improvements, are being considered.

MEETING AGENDA

This informal, open house public meeting is one of two separate, yet identical meetings being conducted to provide an opportunity for attendees to learn about the project, become familiar with the study process and provide feedback.
